Bids received after this deadline will be rejected.

The bids will be opened in the presence of Bidders' representatives who choose to attend at Magh 19, 2080, 14:00 hours at the office of **Sanjen Jalavidhyut Company Limited, Kapanmarg-03, Maharajgunj, Kathmandu**. Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of **40,000.00** which shall be valid for 30 days beyond the validity period of the bid.
