Sanjen Jalavidhyut Company Limited invites sealed bids or electronic bids from Nepalese eligible bidders for Interior Construction and HVAC with VRF, Electrical System Supply, Installation & Commissioning works on the Seventh Floor of Chilime Tower, Dhumbarahi, Kathmandu with contract identification number SJCL/CT/IW/NCB/01/2081-82 under National Competitive Bidding procedures. The estimated amount for the works is **Rs 16,720,157.89** with VAT and Provisional Sum.
2. Bidders are required to submit the document that demonstrate successful completion or participation as a Prime Contractor, Management Contractor, or Subcontractor in at least one (1) similar interior and HVAC project within the last ten (10) years. The project must meet the following criteria:
 - Minimum area of 2,500 sq. ft.
 - Minimum contract value of Rs. 5 million without VAT
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Sanjen Jalavidhyut Company Limited, Kapanmarg-03, Maharajgunj, Kathmandu, Nepal or may visit PPMO website www.bolpatra.gov.np/egp.
4. A complete set of Bidding Documents may be purchased from the office of Sanjen Jalavidhyut Company Limited, Kapanmarg-03, Maharajgunj, Kathmandu, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of NRs. 3000.00 till June 4, 2025 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Company account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held on May 20, 2025, 14:00 at the office of Sanjen Jalavidhyut Company Limited, Kapanmarg-03, Maharajgunj, Kathmandu, Nepal
6. Sealed or electronic bids must be submitted to the office of Sanjen Jalavidhyut Company Limited, Kapanmarg-03, Maharajgunj, Kathmandu, Nepal by hand/courier or through PPMO website www.bolpatra.gov.np/egp or before 12:00 on June 5, 2025. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14:00 on June 5, 2025 at the office of Sanjen Jalavidhyut Company Limited, Kapanmarg-03, Maharajgunj, Kathmandu, Nepal. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **375,000.00** which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
9. The Company (SJCL) reserves the right to accept or reject any bids, partly or wholly or cancel the bids altogether without assigning any reason whatsoever.
